## Car Draw Rules

1. All entrants must be over 18 years and participation is limited to members of Trinity Credit Union and subject to one entry per account. This will include eligible Directors, Supervisors, Staff and Volunteers. All eligible members can elect to participate in the draw ONLY if written authorisation is received or delivered to the Credit Union office.
2. Membership of the draw must be completed prior to participation and no entry is valid unless full fees are paid and credited in advance. Subscription will be €40.00 per year deducted from member's share balance.
3. In event of insufficient numbers, the draw may be suspended, discontinued, or alternative prizes may be given at the discretion of the Board of Directors.
4. The legitimate expenses and overheads of the draw will be borne by the draw fund. Financial accounts at each year-end will be audited by the auditor and presented at the AGM.
5. The draw is non-profit and any surplus funds will be disposed by way of extra draws.
6. In the unlikely event that a winning member is a person who is in any way in default of any of his/her obligations (including, but without limitation, arrears in repayments) to the Credit Union, Board of Directors, at its absolute discretion, may make a decision to withhold delivery and / or payment of any prize won by the said member until such time as any outstanding obligation or financial arrears have been repaid to the satisfaction of the Board of Directors. In the event that the Board of Directors elected to withhold payment and / or delivery of the prize for the reason stated above notice of such withholding shall be furnished to the member in writing. If within seven days of the member being so notified of the requirements of the Board of Directors and the said member fails to discharge the requirements of the Board of Directors in relation to the member's default, the Board of Directors shall be entitled to sell or otherwise dispose of the prize at the best available price. The Board of Directors shall, at its sole discretion, be entitled to deduct from the sale proceeds whatever sum is sufficient to fully discharge the commitments and obligations of the member to the Credit Union. The Board of Directors will then discharge the balance (if any) of the sum so raised to the member.
7. The Board of Directors will not entertain requests for cash or exchange of car, nor will it enter into negotiations with the supplier of the car on behalf of the winner.
8. The Board of Directors and staff of Trinity Credit Union Limited will not accept any liability for any defects, mechanical or otherwise, found in the vehicle supplied or subsequently arising, or for any consequences howsoever arising. Cash will not be given in lieu.
9. The Draw will take place in the office of Trinity Credit Union Limited in the presence of a Director and one of the Supervisors.
10. The Board of Directors of Trinity Credit Union Limited must approve changes in the rules of the draw. The decision of the Board of Directors will be final.
11. Winning members must agree to take part in any promotional activities with Trinity Credit Union Limited.
